Total Transaction Cost	<p>Transaction costs is the term used to describe a number of costs which you can incur when you invest in a fund or funds.</p> <p>The way these costs may be incurred can be summarised as follows:</p> <ul style="list-style-type: none"> <li>• Those incurred by the fund in, for example, buying and selling the shares or bonds it holds.</li> <li>• Those incurred when you buy into a fund or sell out of a fund.</li> </ul> <p>As a result of the calculation method used to produce these costs, there may be funds where, rather than generating a cost, the method results in a 'negative cost' (or profit) or a cost of 0 (zero).</p>
