<b>Explanatory Notes:</b>	<p>In line with Financial Conduct Authority (FCA) and Department for Work and Pensions regulations, workplace pension schemes must perform a value-for-money assessment for their scheme. This includes looking at the charges and transaction costs. This table shows the administration charges and transaction costs for each fund in your workplace scheme.</p> <p>The FCA has prescribed the 'slippage cost' methodology for calculating transaction costs. This calculates the transaction cost of buying or selling an investment as the difference between the price of an asset immediately before placing an order in the market and the price at which it actually trades. We've shown below where fund managers haven't used this methodology.</p>

<b>Administration Charge</b>	This is the fund's annual administration charge (as a % of the value of the fund) for your section of the scheme.
<b>Total Transaction Cost</b>	This is the total of the annual buying and selling costs and the lending and borrowing costs (as a % of the value of the fund) as shown below.
<b>Buying and Selling Transaction Cost</b>	<p>If the Aviva pension fund is managed to an investment mandate set by Aviva UK Life &amp; Pensions, this is the annual cost to this fund (as a % of the value of the fund) in buying and selling its holdings.</p> <p>If the Aviva Pension fund invests in a fund managed by an external fund manager, this is the annual cost (as a % of the value of the fund) incurred:</p> <ul style="list-style-type: none"> <li>- in buying and selling units in the underlying external fund; and</li> <li>- by the underlying fund in buying and selling its holdings.</li> </ul>
<b>Lending and Borrowing Transaction Cost</b>	This is the annual cost (as a % of the value of the fund) incurred by either the Aviva insured fund and/or the underlying fund in lending and borrowing its holdings.
