### WE MAY COLLECT AND PROCESS THE FOLLOWING PERSONAL DATA ABOUT YOU:

- · Information that you provide directly via our mobile application, for example during app set up;
- · Information that you provide when you when you report any problem with our app
- · If you contact us, we may keep a record of that correspondence, including any phone number or email address you use
- · Information that you provide when completing surveys that we use for research purposes;
- Event data collected from sensors installed in your home
- Details of your usage of our mobile application including, but not limited to, traffic data, location data, logs, error & crash-reporting, and other communication data and the resources that you access
- Information available about your usage or configuration of your mobile device, including the presence of other applications, unique device-identifying information, and any cellular network, IP, Wi-Fi or Bluetooth data
- Information you give us explicit permission to access from your mobile device, including your address book, photos, geolocation, gyroscopes, data from your cameras or microphones. You may choose not to give permission to share this data, but it may restrict the usage of certain features of the mobile application
- · Information provided by Aviva to us on registration or when policy details are changed
- · Information provided to us from other third parties who we use to provide our service to you

## WE PROCESS PERSONAL INFORMATION FOR THE PURPOSES OF:

#### **USE OF IP ADDRESSES**

We may collect information about your computer, including where available your IP address, operating system and browser type, for system information and to report aggregate information to our advertisers. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

#### WHERE WE STORE YOUR PERSONAL DATA

The data we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services.
